20 May 2020 - The One Planet Business for Biodiversity (OP2B) coalition welcomes today's publication of the **European Commission Biodiversity Strategy for 2030***. With a strong focus on making agricultural production in Europe more sustainable, the measures set out will help safeguard nature and drive collective action across sectors.

Coordinated political action at the EU level and ideally beyond, underpinned by a strong regulatory framework, is essential for preserving biodiversity. OP2B members will continue to contribute, working with farmers and others to transform practices in supply chains and reduce the environmental footprint of agriculture. Member companies aim to meet evolving consumer demand for diverse foods, flavors and beauty products, creating the right market conditions for supporting the transition.

Agriculture is part of the solution to the many environmental challenges we face. Regenerative farming practices contribute to protecting soil health and water, improving biodiversity, enhancing resilience and keeping more carbon in the ground, while also enhancing farmers' livelihoods. Actions focus on three pillars:

- Eliminating deforestation / enhancing the management, restoration and protection high value natural ecosystems.
